

## Flexible Nine Course Substitution Petition Process

### Overview

In special circumstances, students may petition to substitute a General Education Flexible Nine course with another approved General Education course. These requests are for situations where it is difficult to take the approved Flexible Nine course and where the substitution will make it possible for the student to graduate without an additional semester of course work.

### Students may request a substitution for one of the following Flexible Nine Courses:

- COMM 1130 Public Speaking
- Civics Course: POLS 1110, HIST 1110, HIST 1120, SOCI 2310
- Literature Course: ENGL 1410, ENGL 2310, ENGL 2650, ENGL 2660
- STEMH Course: ENVS 2130, PSYC 2120

Students may only request substitution courses that are listed in Areas I-VI as General Education Courses from the appropriate NNMC Academic Catalog or courses that are approved General Education at the institution where the student completed the course.

Students will need to discuss such requests with their Program Advisor and request approval from the appropriate Chair of the Department that oversees the Flexible Nine course.

Please read the information below carefully and follow the guidelines to complete the Petition Form.

### Petition Process

Students will meet with their Program Advisor to discuss the petition to substitute a Flexible Nine course. If the Program Advisor agrees, students will proceed to the next step.

Students will complete the Petition to Substitute a General Education Flexible Nine Course **Form A** if they are using an approved substitution and **Form B** if they are not. **Form A**

Students **who are not using one of the approved substitutions, will submit Form B** and a course syllabus/course description from the suggested substitution to the appropriate Academic Chair and the Program Advisor.

The Academic Chair will approve or deny the request within two weeks. If the request is denied, the Academic Chair will return the form to the student, the Program Advisor, and the General Education Committee Co-Chairs. If the request is approved, the Chair will submit the form to the General Education Co-chairs for signature. Then, the academic chair will submit the form to the Office of the Registrar with a copy to the student, the Program Advisor, and the General Education Committee Co-Chairs.

Note: Registrar's Office will create a notification in Degree Works that exceptions to the Flex 9 can only be completed by the Registrar's Office. Once substitution petitions are approved, the Registrar will make the exception in Degree Works.

The table below lists NNMC courses that you can use to substitute one of the required Flexible Nine courses. You will need to discuss your proposed substitution course and your situation with your Program Advisor first. If your Program Advisor approves, you must follow the Petition Process and complete the Flexible Nine Substitution Petition Form. Please note that you cannot use a substitution course in Areas 1-6 and as a Flexible Nine substitution.

2. PSYC 1110 Introduction to Psychology
3. ARTS 1410 Introduction to Photography
4. FDMA 1110 Film History
5. FDMA 1210 Digital Video Production I
6. PSYC 2120 Developmental Psychology

You may also propose a course you took at another institution provided that the course was approved for General Education at the institution where you completed the course. Your Program Advisor can help you make that determination.
